Tracy DeLucia is a Nashville recording artist who brings a fresh, distinctive power vocal to today's Adult Contemporary Country scene.



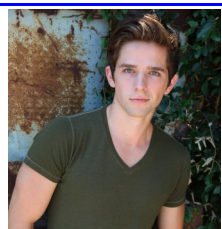
HOTROD **Wednesday, August 2**
